ARTIST'S DISPLAY CONSIGNMENT AGREEMENT**

This Agreement between Yates County Arts Council Inc., (dba: Yates County Arts Center) known as Yates Gallery, 119 E. Elm Street, Penn Yan, New York 14527 herein designated as the Consignee, and _____, herein called "The Artist", also herein designated as the Consignor, residing at the following address: _____

and shall continue so long as the Artist has artwork in Yates Gallery, and

Wherein the Parties Agree as Follows:

1. That all 2-dimensional entries submitted by the Artist will be dry, clean and ready to hang with sturdy picture wire. No clips or other type of hanging devices will be acceptable. Identification labels will be attached to the entries indicating the name, phone number of the Artist, title of work, medium and price.
2. That YCAC holds items delivered by the Artist to Yates Gallery, and such items shall be at all times subject to and under the direction and control of the Artist, except the Artist agrees to leave specified artwork for the term of the Exhibit unless special arrangement has been made with the Exhibit Chair.
3. That title to items shall pass directly from the Artist to the Purchaser in the manner and terms set forth by the Artist.
4. That YCAC shall keep items for the benefit of the Artist and attempt to sell such items for the benefit of the Artist at the Yates Gallery.
5. That YCAC shall not be liable for any loss or damage to the items by theft, fire, or otherwise, whether or not covered by insurance, except as the result of gross negligence of YCAC.
6. The Artist hereby agrees not to sue YCAC for any such loss or damage not arising out of the gross negligence of YCAC.
7. That all artwork for a specific exhibit will be delivered by the designated registration date and picked up by the designated removal date unless special arrangement has been made with the Exhibit Chair.

8. That YCAC will immediately return to the Artist or hold in a rotating inventory all unsold items after completion of the exhibit.
9. Sales of artists' items shall be made by Yates Gallery only for the price set by the Artist. YCAC shall remit to the Artist upon any such sale all of the proceeds of such sale less YCAC standard commission in the amount of 35%.
10. The term of the display or exhibit shall be until it is sold, or YCAC or the Artist requests its removal or return.
11. The Consignor (Artist) hereby agrees to abide by all conditions contained in this Agreement.

This Agreement becomes effective when it is signed by the Artist and an Authorized representative of Yates County Arts Center.
